Sanction is hereby accorded as recommended by the Selection Committee framed under SO 364 dated 27-11-2020, sanction is hereby accorded to the engagement of the following doctors as Senior Residents/Demonstrator in the various disciplines of Government Medical College & AH Udhampur notified vide No. 09 of 2025 dated: 15.10.2025 on tenure basis for a period of one year (extendable up to three years) against the available vacancies as annexed at **Annexure 'A'**.

The selections are made strictly as per **Government Order No: 383-JK (HME) of 2024 Dated: 20.06.2024** and **Government Order No: 382-JK (HME) of 2024 Dated: 20.06.2024**.

The appointed candidates shall be allowed to join only on production of the following documents/Certificates in original.

1. Date of Birth Certificate.
2. All Qualification Certificate.
3. Affidavit duly attested by 1ST Class Magistrate.
4. Domicile Certificate, UT of J&K.
5. Any other document as required under rules.

The details of all Ineligible candidates who have applied for the post of Senior Residents is annexed as **Annexure 'B'**.

Terms and conditions of Engagement:

1. The selected doctors shall submit their joining report in the office of Principal GMC, Udhampur within **07 days (by 4PM Sharp)** from date of issuance of this selection order.
2. The selected candidates must submit an affidavit duly attested by a First-class Magistrate to the effect that:
(a) He/She is non-PSC candidate and in case of PSC Candidate he/she shall submit NOC from the competent authority and proper relieving from the parent department within a period of 15 days from the publication of this order, failing which he/she will not be allowed to join in this institution.

(b) The appointee shall complete their sanctioned tenure and must provide one month's prior notice before resigning from the post.

3. First month's salary of the candidate will be retained as security deposit with the accounts department and shall be disbursed on successful completion of the tenure of appointment.

4. The Senior Residents/Demonstrator are required to submit an undertaking to the effect that he/she has read the aforesaid terms and conditions and shall abide by the same on an affidavit duly attested by First Class Magistrate before he/she is allowed to join.

5. The appointee must submit their joining report to the undersigned only after a formal letter sent to the departments concerned after ensuring that all the requisite formalities have been completed.

6. Salary will be disbursed only after receipt of a proper CID verification report of selected candidates.

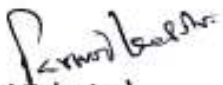

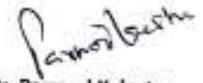
