ORDER

Whereas, in pursuance to Advertisement Notice No. 08 of 2023 dated 04.05.2023, read with Addendum No. GMC/UDH/23-24/143 dated 09.05.2023, the Final Conditional Selection List of 30 Junior Staff Nurses was issued vide Order No. 20 of GMCU dated 23.08.2023 endorsed under no. GMC/Estt/Udh/25-26/2084-92, dated 23.08.2025;

Whereas, the selected candidates were accordingly directed to join within seven days, and were required to submit their original documents for verification as per the terms and conditions of the ibid order;4

Whereas, Para-2 of the terms and conditions explicitly stipulates that *"any discrepancy found in the documents will lead to the rejection of their candidature"*;

Whereas, upon detailed verification of the documents submitted by the appointees, it was found that three candidates namely Radha Rani, Bandhana Devi and Janu Sharma did not meet the minimum eligibility criteria prescribed for the post and were accordingly found ineligible;

Whereas, Show Cause Notices were issued to the said three candidates, giving them an opportunity to explain and fulfil the eligibility criteria;

Whereas, the replies submitted by the candidates were duly examined, and legal opinion was sought from the Associate Law Officer, GMC Udhampur;

Whereas, in accordance with the decision taken in the minutes of the meeting held by the selection committee held on 22nd Nov.2025, and as per the legal advice furnished by the ALO, the committee resolved that the said three candidates failed to fulfill the minimum prescribed eligibility criteria and the discrepancies remained unresolved despite the opportunity provided to them

Now, therefore, in view of the facts established during verification, the replies submitted by the candidates, and the legal advice tendered by the Associate Law Officer, the candidature of the following three candidates is hereby rejected and stands cancelled with immediate effect.
